

Unmixed plastics – a valuable resource

70% of the textiles in our collection are unmixed, i.e. made of 100% Polyester FR or Trevira CS, and are therefore easily recyclable. These unmixed polyester fabrics are a particularly valuable resource and can find further uses via various recycling methods.







Together with you to a better future

If our polyester fabrics no longer meet your requirements in terms of appearance and functionality after use, we would like to ensure that they remain available for other applications for a long time to come.

Thus, together with you, we responsibly solve the disposal problem and return the used textiles to an economically sensible cycle. The fabrics are reprocessed as felting materials for the automotive and construction industries, where they can be used for many decades to come.










The Delius Circular System

ReTurn note on delivery note

Here, the assembler will find information about the DELIUS ReTurn system.

ReTurn sewing-in labels with QR code

Upon delivery of the goods, we will provide you or your garment manufacturer with sufficient ReTurn sewing-in labels. Please sew the label into the curtain. This ensures your right to return the fabrics to us even after many years. And it shows your responsible and sustainable actions to the outside world.









ReTurn in just three simple steps

- 1. Collect your used ReTurn DELIUS curtains, recognizable by the ReTurn sew-in label or the bill on the delivery bill.
- 2. Please remove sling rods, lead tapes, hooks and curtain rolls.
- 3. Send us an e-mail to return@delius.de or contact us directly to inform us about the planned return.

Currently we can only take back fabrics from EU countries for recycling.



What happens to substances that are not unmixed?

Some of our fabrics require special material blends in order to fulfil the necessary functions. As of today, blended fabrics cannot be returned for recycling. Please continue to dispose of these fabrics yourself, we do not take them back. These include:

- DELIBLACK articles with acrylate soft coating
- DELITHERM fabrics (except Gamma)
- DELIGARD upholstery fabrics
- faux leather
- DELIWALL wall coverings
